## Terms & Conditions

1. By completing a booking for the rental of a property you are entering into a contract between you (herein known as the Client) and the Agent and consenting in full to these Terms and Conditions.
2. Rental Fee: ..... (to be notified by the Agent)
3. Deposit: 25% of the Rental Fee will be required to confirm your booking
4. The balance of the Rental Fee is payable not less than 30 days prior to arrival
5. Payments: You must pay via Paypal using your account (if you have one) or by using an approved credit card via Paypal (which can be done without setting up a Paypal account). All payments to be made in US\$
6. Damage Deposit: In addition to the Rental Fee you will be required to pay \$150 against any damaged or missing items at the property. This will be returned in full or in part (as applicable) within 14 days following departure. Any deduction to be made will be notified as soon as possible, in respect of which the decision of the Agent is final and binding. For rentals in excess of 2 weeks a charge of \$10 per week will be deducted for gas
7. Entry: On arrival all members of your party must present their passports at the gatehouse where details will be recorded

8. Occupation: No one other than the named members of your party is permitted to occupy the property
9. Pets: are not permitted except with prior approval. If you wish to bring a pet please notify the Agent in advance. Any request will be referred to the property owner who may refuse consent without reason. There are cattle grazing on the New Cambium estate and other animals and it is the responsibility of the Client to ensure that pets are kept under control at all times and do not cause a nuisance to other occupiers or to the cattle or other animals. Any mess must be cleared up and the Client will be liable in full for any damage caused
10. Cancellations & Refunds: these will be made according to the following schedule:

11. Access: The Client is entitled to access all parts of the New Cambium estate except for other private properties, their gardens and surrounding facilities such as private pools, etc.
12. Code of Conduct: this is set out in full below and applies equally to owners and visitors alike.

You should at all times and in all circumstances behave in such a way as you can be certain that you will not cause offence to others. If you find you are subjected to behaviour you deem unacceptable please report the incident to a member of the management team. Repeat offenders will be required to vacate New Cambium and may not be permitted to return.
